

TREATY OF FRIENDSHIP AND MUTUAL RECOGNITION BETWEEN JUCLANDIA AND LOSTISLAND

Preamble

Whereas the nations of the **Kingdom of Juclandia** and the **Federal Republic of Lostisland**, driven by the common goals of friendship and respect, have agreed to formalise a treaty of mutual understanding in recognition, friendship and diplomacy, hereby established;

- (1) This Act may be cited as "**Juclandia and Lostisland Treaty Act**" or "**Lostisland and Juclandia Treaty Act**";
- (2) The Parties shall henceforth be represented in the treaty by the following representatives:
 - a. Ricardo Oviedo Garbiso, Royal Secretary for Foreign Affairs, on behalf of the Kingdom of Juclandia;
 - b. Yaroslav Mar, President, Irina Sopas, Prime Minister on behalf of the Federal Republic of Lostisland;
- (3) It shall be lawful for the Juclandian Royal Secretary for Foreign Affairs and the Lostislandic President and Prime Minister to declare by proclamation that, on and after a day therein appointed, not being later than three days after the passing of this Act, the Parties shall have signed such a treaty as to formalise the aforementioned aspects of mutual understanding;
- (4) The Act shall take effect on and after the day so signed by both parties;
- (5) The provisions of this act shall remain in place for as long as the Parties exist, unless the treaty is formally deemed invalid by one or both Parties;

Realising these general principles, the parties agree to the following:

Article I

This present treaty specifies the conditions by which the Parties to this agreement will adopt a policy of mutual recognition and friendship, and by which the Parties to this agreement will establish formal, bilateral diplomatic dialogue. Any obstacles that may appear in regards to this process, such as territorial disputes, shall be settled in a period of 30 days from the signing of this treaty or from the moment the conflict arises. If the conflicts are not resolved, the treaty shall be automatically deemed as invalid;

Article II

On the question regarding the establishment of mutual diplomatic recognition, the Parties agree to the following:

- (1) The Kingdom of Juclandia will recognise the independence of the Federal Republic of Lostisland as well as her sovereignty on her territory and her territorial integrity;
- (2) The Federal Republic of Lostisland will recognise the independence of the Kingdom of Juclandia as well as her sovereignty on her territory and her territorial integrity;
- (3) On the occasion of a territorial dispute, sections 1 and 2 or this article shall be applied only to that territory not situated in the conflict. All other actions are provided by Article I of this Treaty.

Article III

On the question regarding the establishment of diplomatic dialogue, the Parties agree to the following:

- (1) The Parties shall establish diplomatic dialogue between their respective government representatives, directly, through meetings, or indirectly, through embassies;
- (2) Direct dialogue shall be done through bilateral and friendship state visits or through direct communication, using special network services;
- (3) Embassies shall be established by the states in conformation to their national laws that regulate the status of such embassies.

Article IV

On the question regarding the common friendship of the Parties, it is agreed to the following:

- (1) The Parties shall conduct their affairs in an atmosphere of mutual respect;
- (2) The Parties shall never proceed to the use of military force in their mutual relationship;
- (3) The Parties shall develop an atmosphere of friendship and cordiality between their two governments;
- (4) The Parties shall not involve in each other's internal affairs and policies, neither in each other's foreign stances and policies.


Article V

This Treaty shall apply to the Parties' respective territories. It shall enter into force on the date on which parties have signed and ratified this treaty, completing their respective procedures for the entry into force of this Treaty.



Article VI
