

# TREATY ON ETERNAL FRIENDSHIP AND ALLIANCE BETWEEN THE FEDERAL REPUBLIC OF LOSTISLAND AND THE GRAND PRINCIPALITY OF PAVLOV

IN THE NAME OF GOD, THE MOST GRACIOUS AND THE MOST MERCIFUL

**WHEREAS** the nations of Lostisland and Pavlov, humbly relying on the blessing of Almighty God, inspired by their common roots and history, recognizing one another as independent and sovereign micronations, in order to form a perfect union, concluded to establish Eternal Friendship and Alliance, hereby do ordain, promote and promulgate the following Treaty:

## **Basic Provisions and Responsibilities of the Parties**

### **Article 1.**

The Grand Principality of Pavlov becomes an associated state of the Federal Republic of Lostisland. Citizens of Pavlov receive Lostislandic citizenship.

### **Article 2.**

The Federal Republic of Lostisland undertakes to defend the well-being of the Grand Principality of Pavlov, its sovereignty in case of foreign aggression; if requested by the Government of Pavlov – to represent and speak on behalf of the Principality.

### **Article 3.**

The Grand Principality of Pavlov, if requested by the Government of Lostisland, undertakes to provide support for the Federal Republic; means of such support are to be decided by the two countries' Heads of State. The Grand Prince of Pavlov undertakes to appoint the President of Lostisland the Crown Prosecutor of Pavlov.

### **Article 4.**

Both parties undertake to:

- 1) Implement a joint political, economic and cultural space, through eliminating border control for each other's citizens, creating a customs

- union, endorsing joint cultural events and taking other measures that the countries' Heads of State see fit;
- 2) Respect each other's customs and traditions.

#### **Article 5.**

The Grand Principality of Pavlov is recognized as the successor in dignity to the Kingdom of Pavlov; the Federal Republic of Lostisland, through its Federation of Belastrova, is recognized as the legal successor of the Kingdom of Pavlov.

#### **Validity, Amendments and Entrance into Force**

#### **Article 6.**

This Treaty comes into force once signed by the two countries' Heads of State (the Prince of Pavlov and the President of Lostisland).

#### **Article 7.**

Amendments to this Treaty are to be made through Joints Decrees of the Prince of Pavlov and the President of Lostisland.

#### **Article 8.**

This Treaty is signed for an unlimited period of time, but can be terminated by both parties' agreement.

***We, the undersigned Heads of State of the Glorious Nations of Pavlov and Lostisland, being of sound mind and memory, having reunited through electronic venues in the global cyberspace on the 16<sup>th</sup> of September 2014, pledge to respect, honor and abide the conditions of the foregoing Treaty, in its entirety and without prejudice. So help us God, the Creator of All Things Made.***
