

MUTUAL RECOGNITION AND COOPERATION AGREEMENT

Between



WORLD HUMANITY COMMISSION [WHC]

represented by its World Chairman | President – H.E. Dr. Sir Zelly MIGHTY, D.Div; D.hc; KSB; KSP

and



FEDERAL REPUBLIC OF LOSTISLAND

represented by its President – H.E. Yaroslav Mar
and its Minister of Foreign Affairs – Hon. Ilian Kostov



WHEREAS:

The Federal Republic of Lostisland, as a global sovereignty, a cultural and social project and an international organization, and the World Humanity Commission [WHC] is an independent worldwide specialized organization for humanity whose daily humanitarian missions, domestic and diplomatic roles within world communities is building the humanity humankind deserve; restoring a complete feeling of self-worth; providing better platform upon peaceful coexistence across people of ethnical, social, political and religious lines. Therefore, each party desires and has expressed a willingness to enter into this Treaty, have agreed, among other, to establish “a perpetual state of friendship and cooperation”, as well as to “share information relating to the development of the institutions and symbols”, believing that international relations – mutual recognition and cooperation – domestic and diplomatic missions are part(s) of the means to achieve sustainable development of humanity.

OBJECTIVES:

The parties are desirous to hereby formalize the bonds of affiliation and cooperation which have grown to work together in a transparent manner to maximize engagement and results for promoting the science and technology for sustainable development worldwide.

NOW THEREFORE, IT HAS BEEN AGREED AS FOLLOWS:

ARTICLE 1

Both the World Humanity Commission (WHC) and the Federal Republic of Lostisland hereby grant each other full recognition as existing organizations with proven track record in sustainable development and humanitarian services.

ARTICLE 2

In order to attain the objectives stated in this agreement both parties shall serve as the think-tank to each other as well as hereby appoint representatives, and establish to set up diplomatic missions in its premises and serving in the pleasure of the “World Chairman | President of World Humanity Commission” in association with the “President of the Federal Republic of Lostisland”.

ARTICLE 3

The parties, in the spirit of affiliation and cooperation existing between them, shall consult together on matters of mutual concern and interest in times of need and in particular to promote concepts, technologies and applications of science and technology for sustainable development

ARTICLE 4

The parties will use their best efforts to encourage cooperation between them to coordinate, facilitate and implement various sustainable development and humanitarian projects and programs.



ARTICLE 5

That the signatories hereto are in agreement that this Treaty forms the foundation of their relationship with one another and may be amended, enlarged and expanded upon the concurrence of both.
