PRESIDENTIAL DECREE 42/2022

On impeding the malicious activity of the Russian Federation and implementing sanctions against Russian and Belarusian residents

WHEREAS the Russian Federation is conducting an ongoing aggression against Ukraine, committing numerous war crimes and crimes against humanity;

IN LIGHT OF the illegal annexation of Southern Ukraine in 2022, Crimea in 2014, and the ongoing invasion of Ukraine; and

WHEREAS the malicious activity of the Russian Federation poses a threat to the national security of the Federal Republic of Lostisland; and

IN LIGHT OF the 2022 annexation of Southern and Eastern Ukraine, the 2022 invasion of Ukraine, the 2014 annexation of Crimea or the 2014 pro-Russian unrest in Ukraine:

- 1. Any Lostislandic citizen, who:
 - a. Praises or condones, publicly or in private, Russian Federation policies or the actions of its self-styled "president" Vladimir Putin, including, but not limited to, the 2022 annexation of Southern and Eastern Ukraine, the 2022 invasion of Ukraine, the 2014 annexation of Crimea, the 2014 pro-Russian unrest in Ukraine, the "Russian world" ideology, or experiences positive emotions in connections

with the above, or fails to recognize the territorial integrity of Ukraine to which the law enforcement authorities became privy;

- b. Celebrates the so-called "victory day" on May 9;
- c. Demonstrates the so-called "ribbon of Saint George" or the letters *Z*, *V*, and *O* in the context of the Russian invasion of Ukraine, except for condemnation purposes —

Shall be excommunicated from Lostisland without the right to appeal and restoration of citizenship.

- 2. A Russian Federation or Belarus resident who applies for Lostislandic citizenship shall be admitted to it —other requirements notwithstanding— only after having demonstrated to the immigration authorities in a due and convincing way their negative attitude to the Russian Federation and Vladimir Putin's policies and a record of opposition activism in these countries.
- 3. Applicants who reside in the Russian Federation or Belarus shall be treated with a presumption of guilt and as a threat to the national security of the Federal Republic unless and until demonstrate otherwise to the immigration authorities in a due and convincing way.
- 4. Clauses 3 and 4 shall apply to all residents of the Russian Federation and Belarus, whether or not they are these countries' citizens, and shall not apply to Russian Federation and Belarus citizens with overseas residency.
- 5. The Federal Intelligence and Security Service (FISS) shall be instructed to increase population policing in order to timely identify unorthodox, unreliable, and astraying citizens, prevent thoughtcrime and minimize the damage to the national security of Lostisland.

6. The Decree comes into force on the day of signing.
