### PRESIDENTIAL DECREE

46/2023

#### On the Establishment and Role of the Council of Elders

**WHEREAS**, the Federal Republic of Lostisland ("Lostisland") seeks to preserve its stability, cultural heritage, and further its development; and

WHEREAS, the collective wisdom, experience, and sagacity of esteemed citizens are invaluable assets in the pursuit of these objectives; and

WHEREAS, the institution of a Council of Elders, tasked with specific responsibilities, is essential to harness such wisdom and experience for the betterment of Lostisland;

**NOW, THEREFORE**, We, Yaroslav Mar, President of the Federal Republic of Lostisland, in pursuance of Our official capacity and in adherence to the legal framework governing Lostisland,

**HEREBY** promulgate this Presidential Decree:

#### Article I: Establishment of the Council of Elders

1. The Council of Elders ("the Council") is hereby established as an official advisory and deliberative body to the President of the Federal Republic of Lostisland.

2. The Council is constituted for the primary purpose of providing counsel and guidance to the President and the government, thereby utilizing the rich experience, wisdom, and knowledge of its members to advance the nation's interests.

#### Article II: Role of the Council of Elders

- 1. **Advisory Function:** The foremost responsibility of the Council is to offer counsel and guidance to the President and the government, drawing upon the profound wisdom and extensive experience of its esteemed members.
- 2. Policy Development and Long-Term Strategic Planning: The Council is assigned the task of participating in the formulation and refinement of policies and long-term strategic plans relating to Lostisland's future trajectory, international relations, and other critical domains, ensuring comprehensive and informed decision-making and establishing overarching goals and objectives.
- 3. **Conflict Resolution:** In instances of internal disputes or discord within Lostisland, the Council may, at the President's request, act as impartial mediators or arbitrators, diligently striving to reach equitable and harmonious resolutions.
- 4. **Cultural Heritage Preservation:** The Council undertakes the role of guardians of Lostisland's cultural or historical heritage, ensuring the preservation of the nation's connection to its origins and legacy.
- 5. **Guardians of Core Values:** The Council members are entrusted with the sacred duty of safeguarding Lostisland's fundamental values and principles, upholding the nation's ethical framework, and ensuring alignment of decisions with these values.
- 6. **Preservation of Continuity:** Serving as a bastion of stability, the Council's wealth of experience contributes to maintaining governance consistency, even as elected officials may change over time.
- 7. **Engagement with the International Community:** The Council may, at the President's request, engage with the broader international community, representing Lostisland's interests, fostering alliances, and nurturing positive relationships with other nations.
- 8. **Educational Role:** Council members play a pivotal role in educating younger citizens and newcomers about Lostisland's history, culture, and values, fostering a profound understanding of the nation's heritage.

#### **Article III: Composition and Selection**

- 1. Membership within the Council of Elders is bestowed solely at the discretion of the President, in accordance with the Presidential Prerogative.
- 2. Eligibility for membership necessitates that individuals, in order to partake in the Council, meet at least two of the following criteria:
  - a. Hold continuous Lostislandic citizenship for a period exceeding five years, demonstrating a profound commitment to the nation.
  - b. Occupy official government positions within Lostisland, reflecting dedication to public service.
  - c. Serve as distinguished Lostislandic diplomats, receiving commendation for representing the nation's interests internationally.
  - d. Possess a full beard, symbolizing attributes of wisdom and experience esteemed by Lostislandic citizens.
  - e. Attain the age of sixty years or older, signifying life experience, wisdom, and sagacity valuable to the Council.
  - f. Hold a Doctor of Philosophy (Ph.D.) degree or an equivalent academic qualification, attesting to their erudition and scholarly pursuits.
  - g. Gain recognition as a religious leader, signifying moral and spiritual leadership.
  - h. Attain Nobel Prize laureate status, demonstrating distinguished achievements in their respective fields.
  - i. Hold membership within Mensa or a high-IQ society with more stringent admission criteria, highlighting exceptional cognitive abilities.
- 3. The President may, at his discretion, waive one or more of the specified requirements for exceptional individuals who possess unique qualifications deemed to be of extraordinary benefit to the Council.

## Article IV: Membership Quota and Tenure

- 1. The composition of the Council of Elders shall not exceed a maximum limit of seventy members, to ensure effective and organized deliberation.
- 2. Council members shall serve for life, subject only to voluntary resignation, dismissal by the President, or forfeiture of Lostislandic citizenship, symbolizing the solemn and enduring nature of their duties.

## **Article V: Special Invitations**

The President, in accordance with the governing law and constitution of the Federal Republic of Lostisland, may, on special occasions, extend invitations to

distinguished foreign dignitaries whose presence and contributions would be deemed indispensable to the deliberations of the Council of Elders.

## **Article VI: Initial Appointments**

- 1. At the time of its establishment, the following individuals are appointed as initial members of the Council of Elders:
  - a. Rt. Hon. Mordechai Moshe Linhart, Prime Minister, Chief Rabbi, Ambassador to Israel
  - b. Justice George Oprea, Praesus of the Supreme Court
  - c. Hon. Ilian Kostov, Minister of Foreign Affairs
  - d. Justice Mathias L. Mayaan-Baruch, Member of the Supreme Court
  - e. Justice Denys Tezdzhanenko, Member of the Supreme Court, former Prime Minister, former Minister of State Security
  - f. H.E. Dr. Andrej Golubew, Ambassador to Russia, former Minister of Health
  - g. H.E. Kit Llorca, Ambassador to the Philippines

This Decree, in furtherance of the loftiest objectives and ideals of the Federal Republic of Lostisland, shall enter into immediate and irrevocable effect upon its issuance.
